MEMBERSHIP TERMS & CONDITIONS

1.1 ENROLLMENT: To enroll in the JonEvac Distributor Membership Program, a completed online registration and payment of a \$799.00 Membership Fee are required. Membership is valid for 1 year from the enrollment date and can be renewed upon expiration. Within 30 days from completion of enrollment, the Distributor will receive a JonEvac welcome package that includes the printed marketing materials listed in the preceding section under "Membership Benefits". Additional business cards, brochures and other marketing materials can be purchased individually at the Distributor's JonEvac website as needed. Reproduction, photocopying, or any form of duplication of JonEvac business

cards, brochures, or other marketing materials without prior written consent of JonEvac Corporation constitutes a violation of JonEvac's copyright and trademark and is strictly prohibited. JonEvac Corporation reserves the right to prosecute or terminate our business relationship with anyone who engages in such conduct or violation.

1.2 MEMBERSHIP RENEWAL: Upon expiration, the JonEvac Distributor Membership can be renewed for \$799.00 for another term of 12 months from the renewal date. The Distributor will receive a new JonEvac welcome package that includes the printed marketing materials listed in the "Membership Benefits" section upon renewal of each expired membership.

1.3 The Membership fee is non-refundable, and the Membership benefits are non-transferable.

1.4 The JonEvac Distributor is not an employee or affiliate of JonEvac Corporation.

2.1 WHOLESALE PRICING: Qualified Distributors will receive volume-based wholesale pricing with a Discount of 10-30% from the MSRP for the JonEvac products published at www.JonEvac.com.

3.1 REFERRAL COMMISSION: Qualified Distributors will receive a 10% Referral Commission on all membership enrollment fees and purchases made on the Distributors' JonEvac Replicated Website. The distributor will also receive a 2% referral bonus commission on all membership enrollment fees and purchases by those enrolled by his/her referrals. The Referrer must have a current Distributor Membership account and purchase a minimum of 1 JonEvac Ventilation System per month, or 12 JonEvac Ventilation Systems within 12 calendar months from the membership enrollment or renewal date to qualify for referral commission or referral bonus commission benefit. Freight and Sales Tax are exempt from referral commissions.

Referral Commissions will be paid by Direct Deposit on the 20th day of the current month for qualified referral transactions in the commission period ending on the 15th day of the current month and paid by the 5th day of next month for qualified referral transactions in the commission period ending on the last calendar day of the current month.

4.1 PAYMENT TERMS: Full payment is required for membership enrollment fee and purchase of JonEvac products. JonEvac Corporation does not provide in-house financing, so the customer/distributor has the sole responsibility of securing the necessary financing for his/her purchase of any JonEvac product. There is a \$35.00 NSF fee plus legal fees and court costs for collecting any customer payment or check that is dishonored by the financial institution.

4.2 JonEvac Corporation reserves the right to change any of the JonEvac Distributor Membership Program requirements and benefits, including but not limited to Product Pricing, Membership Fee, Freight Cost, etc., without prior notice to the Customer or Distributor.

5.1 SHIPPING POLICY: JonEvac Corporation ships via UPS and independent trucking companies for deliveries within the USA, Canada, and Mexico. Shipments to other international destinations are done via ocean freight or air freight. All products are packed in accordance with UPS shipping standards and insured for the value of the product. There's a \$499.00 handling charge per order on shipments to Alaska, Hawaii, and all international destinations.

- Orders will not be shipped on weekends or holidays.

- Due to high demand for JonEvac, the products are expected to ship within 30 days from the order processing date. If an item is on back-order, the delivery can be up to 90 days from the invoice date.

- As soon as your order ships, you will be sent an e-mail containing the tracking number. All shipment tracking should be handled directly with the transporter, referencing the shipment's tracking number.

5.2 BACK-ORDER POLICY: We will notify you of any shipment delays, giving you the opportunity to decide whether to cancel the order or hold it on back-order. If part of your order is in stock, you may receive an initial partial shipment of the order pending later shipment of the back-ordered items (with your approval). Back-orders typically ship within 60-90 days.

6.1 RETURN POLICY: We will exchange or refund the full purchase price for any JonEvac product that does not meet your expectations, if returned within 30 days of purchase in its original packaging. The product must appear normal with no sign of use or abuse. Please call 713-995-5500 or email returns@JonEvac.com and request a Returns Authorization Code before returning any product.

7.1 DAMAGED GOODS POLICY: All products are inspected before shipping, but damage may occur during transport. If a product is received in a damaged condition, it must be reported to the shipping company at the time of delivery, and to JonEvac Corporation, at: returns@JonEvac.com or phone: 713-995-5500 within 24 hours from the delivery date. All boxes and packaging materials must be saved because it's possible that the shipping company may want to inspect these materials when processing the damaged goods claim. A replacement product will be shipped to you upon our retrieval of the damaged goods.

8.1 INSTALLATION: Complete installation instructions are included inside the shipping box of your new JonEvac Ventilated Toilet Seat System. You can also watch the installation video on our website, www.JonEvac.com/how-it-works for a step-by-step explanation of the installation process. However, you will need a licensed electrician to install a GFCI electrical outlet near your toilet bowl if you don't already have an electrical outlet for your JonEvac's power supply.
